

1719 Will of Deborah Linthorne of Poole, Dorset

Dated: 10 Dec 1719

Proved: 30 Apr 1720

Deborah LINTHORNE of the Town and County of Poole Widow being Weak of Body but of sound and perfect memory, thanks be therefore rendered to Almighty God, considering the uncertainty of time & also certainty of Mortality, do in the fear of God, make and ordain this my last Will and Testament, That is to say principally and first of all I recommend my Soul to the hands of God who gave it, and my Body I committ to the Earth, And as touching such Worldly Estate wherewith it hath please God to bless me in this life, after my Debts & funeral expenses are paid & Discharged I gve devize dispose of the same in manner & form following (vizt):

Imprimis I give bequeath unto my Sons (viz.) **Thomas LINTHORN John LINTHORN Henery LINTHORNE** and to my Daughter **Elizabeth ROGERS** – to each one of them one shilling to be paid unto them by my Executrix hereafter named, if lawfully Demanded,

Item I give, grant, Devize & bequeath unto my Daughter **Hannah BIRD**, all and singular my messuages, Tenements, & Dwelling houses, scituate, lying or being, within the Town and County of Poole aforesaid, with all & Singular Outhouses Gardens, Lands, Backsides, Outlots, Ways, Paths, Passages, Easent? profits, priviledges, Advantages, Commidities, Emoluments, Hereitaments, and appurtenances, to whom, and to every, or either of them belonging or in any Wise appertaining To have and to hold, all and singular the said messuages Tenements, Dwelling houses, with their and each & every of their Rights, Members, and appurtenances, hereby given granted and Devized or intended to be hereby Given, Granted Devized unto my Said Daugher **Hannah BIRD**, her Heirs and assigns forever. The my said daughter **Hannah BIRD** paying, or causing to be well and truly paid, unto my Son **Thomas LINTHORNE** the sum of Sixty & five pound with the Lawfull Interest thereof. **And whereas** I did by Articles of agremt: grant to my Said Son **Thomas LINTHORNE** the liberty to Erect a workhouse; or other Building on the Piles belonging to one of my Tenemts: herein before given to my Said Daughter **Hannah BIRD**, and also Liberty to Inclose from the Sea, and enlarge the same, to hold unto my Said Son **Thomas LINTHORNE** for the Terme of Twenty Years if he and his **Wife** should so long live, under divers covenants, therein contained I do therefore hereby give Devize bequeath the Reversion & Inheritance of the said house so to be erected, or so Erected to my said Daughter **Hannah BIRD** & her heirs & assigns forever the my said Daughter **Hannah BIRD**, paying the severall Sums of Money & performing the Covenant & agreemt: in the said articles mentioned.

Item I further give devize & bequeath unto my said Daughter **Hannah BIRD** all my Ready moneys, credits, Household Goods, and all & singular other my goods & Chattells whatsoever whom I hereby also make & ordain my whole & Sole Executrix of this my last Will and Testament, And I do hereby revoke Disannull and make utterly void all other Wills by me made, and do ratify and confirm this to be my last Will and Testament. In Witness whereof I have hereunto sett my hand and Seale the Tenth Day of December in the year of our Lord Christ one thousand Seavon hundred and nineteen.
